- bench tests and measurements and road tests and measurements, mainly for automotive industry customers, as well as tests and measurements of materials, components and finished products for other industries;
- testing for type approval of a specific vehicle or type of vehicle,
- production of individual or small series of parts for vehicles and vehicle equipment, as well as workstations and tools for testing and production processes,
- design and development services, calculations, simulations, opinions and expert reports,
- turnkey projects,
- servicing, maintenance checks and MOT inspections of vehicles (these services are supplied by our licensed MOT test station, number: OSKP SB/036).

Given the variety of projects undertaken by the Institute, as well as the requirements and expectations of the parties concerned, the Institute has implemented an integrated management system, which has been certified for conformity with the requirements of the PN-EN ISO 9001/AQAP 2110, PN-EN ISO 45001 and PN-EN ISO 14001 standards. In addition, information security and confidentiality procedures based on the PN-EN ISO/IEC 27001 standard with AL2 TISAX certification are in place. Our testing laboratory and type approval laboratory comply with the requirements of the PN-EN ISO/IEC 17025 standard and are accredited by the Polish Centre for Accreditation (accreditation number: AB 128).
